## Aircraft Rental Release Form

In consideration of the fact that there is inherent danger in operating aircraft, I, \_\_\_\_\_, being of lawful age or if under the age of 18 years old authorized by my parent or legal guardian as undersigned and in consideration of my anticipated flight(s), agree intending to be legally bound hereby, liable for my death or injury to my person, or for any loss or damage to my property caused in any manner whatsoever whether attributable to the negligence of the aforesaid pilot and or instructor and/or operator and/or owner, or for any other reason, occurring during the time that I am in, entering or alighting from an aircraft piloted by myself or under the control of instructor/pilot/owner, and I do hereby waive any right of action against the aforesaid pilot/operator/owner from any and all causes of claims that I may have against them from the beginning of time until these presents. I further agree not to sue on such cause or claim and release, acquit and discharge Vinland Aerodrome, Inc., its officers, directors, shareholders, employees, independent contractors flight instructors, and all other persons and entities who may be directly or indirectly liable, from any and all actions, causes of action, claims, demands, costs, loss of service, expenses and compensation, that I might sustain arising or in any way growing out of, and all known and unknown personal injuries and property damage resulting or to result from the use, operation or control, of any aircraft owned, leased, or operated by Vinland Aerodrome, Inc. I fully understand that it is my duty to do preflight inspections of the aircraft and to assure that the aircraft is in a safe condition for flight.

The terms of this release will also apply when I am a passenger, pilot, or pilot receiving instruction from another pilot, in a Vinland Aerodrome, Inc. aircraft or while I am about or around aircraft on the ground.

I understand that I am personally responsible for any damage caused to the airplane while I am renting it, and any damage I cause to the airplane. I am aware that I have been advised to purchase aircraft rental liability insurance on myself and if I chose not, it is at my own risk.

I understand that I am aware of the risks and accept full responsibility of the risks. I acknowledge that I have carefully read the foregoing release and know and understand the contents thereof, have asked for clarification if I did not understand, and I sign this release voluntarily as my own free act with full knowledge of its significance, intending to be legally bound thereby.
